**Subject:** Notice of Intent (NOI) to Adopt a Mitigated Negative Declaration for the Crossover Pipeline Interstate 15 Bypass Project

**Dear Adjacent Landowner or Interested Party:**

The San Diego County Water Authority (Water Authority), as the lead agency under the California Environmental Quality Act (CEQA), has prepared and plans to adopt a Mitigated Negative Declaration (MND) for the Crossover Pipeline Interstate 15 (I-15) Bypass Project (project). The Water Authority is hereby notifying agencies and members of the public that may be interested in the project as to the availability of the Draft MND, and the procedures for public review and comment on the document.

**Project Location:** The project is located within the unincorporated areas of San Diego County, north of the City of Escondido. Construction activities are anticipated to be located within a mixture of Water Authority right-of-way (ROW), County ROW, California Department of Transportation (Caltrans) ROW, and private property. One potential construction laydown area is located within the City of Escondido's municipal boundaries.

**Project Description:** The Water Authority is proposing to implement a project, which would replace and realign an approximately 5,400-foot segment of the existing Crossover Pipeline that runs beneath and parallel to I-15. Development of the new realigned segment of pipeline would be constructed via a combination of trenching and tunnelling methods. During active construction, the affected segment of N. Centre City Parkway would be fully closed and all traffic would be detoured along Mesa Rock Road and Deer Springs Road. The section of N. Centre City Parkway where work is occurring would remain closed for the duration of work but would allow local traffic to access surrounding private properties. The proposed project would also develop new access structures to provide permanent access to this segment of the pipe for inspection and maintenance. Additional appurtenances, such as fiber optics, pull boxes, air vents, and a corrosion test system would be installed along the new segment of pipeline. The segment of existing Crossover Pipeline to be replaced would be removed or abandoned in place. New permanent easements will be requested along portions of the realigned pipeline within private property. No changes to the existing water supply would occur.

**Environmental Effects:** The Draft MND identifies potentially significant impacts with respect to noise, and paleontological resources. Mitigation measures have been incorporated into the project that either avoid or reduce project impacts to less-than-significant levels.

**Availability of Document:** Pursuant to CEQA requirements, a Draft MND is being made available for a public review period commencing on January 12, 2023 and ending on February 12, 2023. The Draft MND and supporting appendices are available for review at the San Diego County Water Authority's website:
